Dear Ms. Trinko:

By this letter, Preferred Sands of Minnesota, LLC ("Preferred") and Frontier Sand, LLC ("Frontier") notify the Town of Cooks Valley that, pending certain conditions, ownership and control of the nonmetallic mining operation referenced above is to be transferred to Frontier on or about December 1, 2017. Ownership of the real property itself is not changing, but will continue to be leased.

Pursuant to this transfer, Preferred and Frontier request that the Town of Cooks Valley Nonmetallic Mining Permit, issued to Preferred on October 25, 2012, be transferred to Frontier as of December 1, 2017. Frontier agrees to assume the obligations as Permit Holder under the permit referenced above, and Frontier agrees that the property will continue to be used for nonmetallic mining activities. Please note that Preferred has not conducted mining operations on the property since approximately 2015, but Frontier intends to recommence operations in the future. Frontier will submit proof of financial wherewithal to comply with the terms and conditions of the permit shortly following closing.

Given the permit's requirement in Condition 11.3 for obtaining the Town's prior written consent to transfer the permit, please kindly review our request and confirm in writing that the Town approves the permit's transfer to Frontier by signing where indicated below and returning to:
